HOLIDAY SAFETY TIPS



Be Careful with Holiday

<u>Candles</u> – Keep candles away from decorations or other combustible materials. Don't leave children or pets unattended in a room with lit candles where they can be knocked over. Keep candles, matches, and lighters out of the reach of children. Avoid using candles during parties. Never display lighted candles in windows or near exits.

Designate a Driver – When attending a party, designate a non-drinking driver. If you are hosting a holiday gathering, be sure there are non-alcoholic beverages for guests who are driving. Remember, that responsibility is yours if you let someone drive home from your party and they have had too much to drink.

Buckle Up – During the holiday months, people travel more than ever. Wearing a seat belt may prevent injury in a motor vehicle collision. Ensure that all passengers are wearing safety belts. Seat children in the back seat of the car and in approved safety seats if younger than six years old, or according to local law.

Recipe of the Quarter: Cherry Lemon Crowns

Cookie Batter:

2/3 cup butter or margarine, softened

- 1 (3-oz) package cream cheese, softened
- 1 cup sugar
- 1 egg yolk
- 1 teaspoon grated lemon rind
- 1 teaspoon fresh lemon juice
- 2 cups all-purpose flour
- 1 dozen each candied red and green cherries, halved

Beat butter & cream cheese at medium speed of an electric mixer until creamy. Gradually add sugar, beating until light and fluffy. Add egg yolk, lemon rind, and lemon juice, beating well. Add flour, beating until blended. Cover and chill dough 2hours.

Shape dough into 1" balls. Place 2" apart on ungreased cookie sheets. Flatten each ball into a 1 1/2"disc. Press a candied cherry half in center of each cookie.

Bake at 350 for 12-15 minutes or until edges are barely golden.

Cool 1 minute on cookie sheets; remove to wire racks and cool completely. Drizzle lightly with Lemon Glaze. Let stand until glaze sets. Yield: 4 dozen

Lemon Glaze

1 ½ cups sifted powdered sugar 1 to 2 tablespoons fresh lemon juice

Combine powdered sugar and lemon juice, stirring well. (Glaze should be thick, yet easy to drizzle) Yield: enough for 4 dozen cookies.
